# Paweł Bujnowski

Mr Paweł Bujnowski holds a Master's degree in Finance and Banking from the Warsaw School of Economics. In addition, he has completed a number of training courses in the areas of accounting, corporate financial management, banking and valuation and business acquisitions and disposals (M&A). He is a graduate of the IESE Business School in Madrid - 'Strategy. Value Creation and Leadership'.

Mr Bujnowski began his career in 2001 by joining the Management Development Programme at Citibank, an international financial institution. For the next 6 years, he was a member of the financial advisory team analysing companies and carrying out M&A transactions, as well as preparing and carrying out capital increase transactions and introducing companies to the Warsaw Stock Exchange (working until 2007 in a Brokerage House). and listing companies on the Warsaw Stock Exchange (working until 2007 at the Brokerage House of Bank Handlowy). He worked in offices in Warsaw and London.

In 2008, Mr Bujnowski joined the financial advisory company Trigon, where he completed dozens of M&A advisory projects as well as company listings on New Connect and WGPW. He carried out projects of a financial and strategic advisory nature for companies engaged in manufacturing, service and distribution activities in the following industries: construction of rail and road infrastructure, printing and press distribution, chemicals, retail trade, telecommunications. He has also been involved in corporate bond issues for private and publicly listed companies.

From 2013 to 2019, he worked as Director of the Investor Relations Office at LOTOS Group S.A.. He then returned to his main profession and took up the position of Director of the M&A team at the Wroclaw-based industrial company SELENA S.A. (sector: construction chemicals) where he worked until 2023 and completed two business acquisitions and numerous projects to reorganise and improve the efficiency of SELENA S.A. group companies.

Moreover, Paweł Bujnowski started his work in the RES (renewable energy sector) at the Estonian company Sunly A/S in 2023 and continues it until now at Green Capital S.A. in Gdynia as Chief Investment Officer.
