TORPOL S.A., with its registered office in Poznań (61-119 Poznań), at 43 Św. Michała Street, entered into the Register of Entrepreneurs kept by the District Court Poznań - Nowe Miasto and Wilda in Poznań, VIII Economic Department of the National Court Register under the KRS number 0000407013, NIP 972-09-59-445, REGON 639691564, share capital of PLN 4,594,000.00 paid in full, is the administrator of your personal data.

4) Redress and defense against claims

processing is necessary for the purposes of the administrator's legitimate interests (Article 6(1)(f) of the GDPR) – defense of the entrepreneur's interests

6 years from the end of cooperation

The Administrator will transfer personal data only to trusted recipients such as IT service providers, postal and courier services, law firms.

As we process your personal data, you have the right to:

- 1) request access to your personal data,
- 2) request rectification of your personal data,
- 3) request the deletion or restriction of the processing of your personal data,
- 4) object to the processing of your data,
- 5) file a complaint to the supervisory authority (President of the Office for Personal Data Protection).
